

CERTIFICATE OF LOCATION LODEMINING CLAIM (NEVADA)

From the discovery monument, the undersigned claims 1490 feet running in a Southerly direction and 10 feet running in a Northerly direction lengthwise of the claim together with 300 feet in width on each side of the center of the lode or vein.
