

CERTIFICATE OF LOCATION LODE MINING CLAIM (NEVADA)

Notice is hereby given that PHELPS DODGE CORPORATION, whose address is 1601 Vassar Street, Reno, Nevada 89502, by its undersigned agent, makes this location of the BAR No. 219 lode mining claim in the Unknown

Mining District Eureka County(ies), Nevada. This claim was located and the notice of location was posted on 6th day of July, 1979.

From the discovery monument, the undersigned claims 1490 feet running in a Southerly direction and 10 feet running in a Northerly direction lengthwise of the claim together with 300 feet in width on each side of the center of the lode or vein. The general course of said lode or vein is from the North to the South. This claim is 1500 feet in length and 600 feet in width.

The discovery monument, at which the notice of location is posted, is located approximately 2,740 feet South and 7,577 feet West from the Southeast Corner of Section 15 T. 23 N., R. 51 E., M.D.B. & M., and said claim is located within the SE 1/4, 1/4, 1/4, 1/4, of Section(s) 21 T. 23 N., R. 51 E., M.D.B. & M.

- East, 300 feet to a Post marked Corner 2, thence
- South, 750 feet to a Post marked Side 3, thence
- South, 750 feet to a Post marked Center 4, thence
- West, 600 feet to a Post marked Corner 5, thence
- North, 750 feet to a Post marked Side 6, thence
- North, 750 feet to a Post marked Center 1, thence
- East, 300 feet to the true point of beginning.
