The description of the claim is as follows:

Commencing at Corner No. 1, the SW Corner, which is common with Corner No. 2 of OMEGA No. 2 Lode Claim and whence the S. $\frac{1}{4}$ Corner of Section 34, T. 19 N. R. 53 E. bears N. 35 28' W. 1562 feet; thence S. 28' E. 879.6 feet to Corner No. 2; thence S. 9 E. 620.4 feet to Corner No. 3; thence N. 62 E. 634.5 feet to Corner No. 4; thence N. 9 W. 520 feet to Corner No. 5, which is common with Corner No. 2 of OMEGA No. 3 Lode Claim; thence N. 28 W. 980 feet to Corner No. 6 which is common with Corner No. 3 of OMEGA No. 2 Lode Claim; thence S. 62 W. 600 feet to Corner No. 1 the place of beginning. Location Monument is a 4 x 6 Wooden Post with stainless steel plate nailed on Post. Side Line Post is set 440 feet between Post #1 and 2 and 490 feet between Post # 5 & 6. They are 4 x 4" Wooden Posts with metal plates marked and nailed on Post. Location work was done by bulldozer and front end loader in open cut across vein contact.
