

CERTIFICATE OF LOCATION
LODE MINING CLAIM

KNOW ALL MEN BY THESE PRESENTS that the undersigned locator, having complied with all of the requirements of law and local rules and customs have claimed and claim by right of discovery and location, a lode mining claim in the Mineral Hill Mining District, County of Eureka, State of Nevada, and hereby certifies that:

(a) The name of said lode or vein and lode mining claim is:

(b) The name and post office address of the locator is:

(c) Said mining claim was located on July 28, 1979, is about in Section 9, T. 26 N., R. 52 E., M.D.B.&M., and is bounded and described as follows:

Commencing at the southeast corner which bears 50 feet southerly and 300 feet easterly from the location monument; thence westerly 600 feet to the SW Corner; thence northerly 1500 feet to the NW Corner; thence easterly 600 feet to the NE Corner; thence southerly 1500 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 1790 feet in a $N8^{\circ}30' W$ direction from SW Corner Sec. 10, T. 26 N., R. 52 E., M.D.B.&M., Eureka County, Nevada. This lode claim, Mt. Hope Mining Co. # 43 is northerly of Mt. Hope Mining Co. # 45, southerly of Mt. Hope Mining Co. # 42, easterly of Mt. Hope Mining Co. # _____ and westerly of Mt. Hope Mining Co. # 44 lode claims.

(d) The undersigned claims 1500 feet, linear and horizontal measurement, along the course of the vein, together with 300 feet in width on each side of the center of the vein, 1450 feet of said lode running northerly from the point of discovery (designated by the location monument). The general course of the lode as near as may be presently determined is northerly and southerly.

(e) Since the date of said location and prior to the date of this certificate, the undersigned caused work to be performed for location upon said mining claim consisting of maps as provided in NRS 517.040.

(f) The location monument, each corner and each side line center marker is in each instance represented by a post at least 4 inches in diameter by $4\frac{1}{2}$ feet in length and set 1 foot in the ground, the respective corner posts being marked as follows: "SE Cor.
