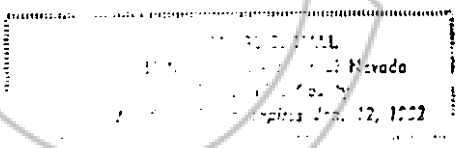
Roger C. Banghart, first being duly sworn, deposes and says:
