

ASSIGNMENT OF MINING LEASE AND OPTION AGREEMENT

NOW, THEREFORE, in consideration of the above and for other good and valuable consideration, the following is hereby agreed:


1. MOUNT HOPE hereby assigns, transfers and conveys all of its right, title and interest in and to said mining lease to HAROLD DRIMMER.
