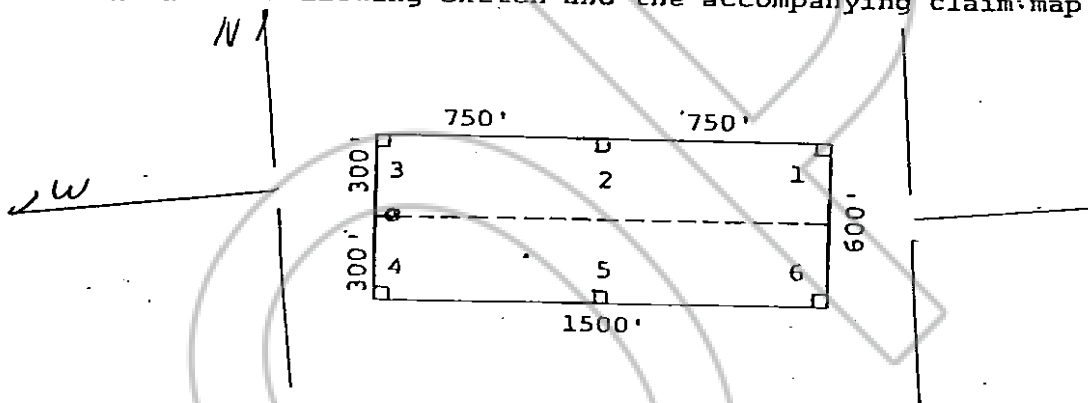

NOTICE IS HEREBY GIVEN that the Selrat No. 71 lode mining claim has been located by AMERICAN SELCO INC. a New York corporation, whose address is 90 West Grove Street, Suite 100, Reno, Nevada 89509. The general course of this claim is N87°W. This claim is 1500 feet in length along the course of the claim, being 10 feet from the point of discovery in a N87°W direction to the West end line of this claim, and 1490 feet in a S87°E direction to the East end line of the claim. This claim is 600 feet in width, being 300 feet in width on each side of the center line of the claim.

This claim is located within the SW Quarter of Section 16, Township 18 North, Range 53 East, Mount Diablo Base and Meridian, Ratto Canyon Mining District, Eureka County, Nevada. The location monument of this claim is situated with reference to some natural object or permanent monument as follows: 14070 feet N 25°W from Claim Location Marker SRI

Claim location marker SRI, a 3" x 6" steel pipe, is located appx.: 1.43 mi N76°E from Grays Peak; 2.50 mi N8°E from South Hill Peak; 0.55 mi S27°W from Surprise Peak
