

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the Pill 55 lode mining claim in the NE quarter of Section 8, Township 28 North, Range 52 East, of the Mount Diablo Meridian, in an unknown mining district, of Eureka County, in the State of Nevada, on the 11th day of September, 1979, for Occidental Minerals Corporation, Irongate Bldg. 4, 777 S. Wadsworth Blvd., Lakewood, Colorado 80226.

The claim is 1320 feet long and 600 feet wide and 1300 feet is claimed in a North direction along the length of the claim and 20 feet is claimed in a South direction along the length of the claim from the Location Mounument at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a North and South direction.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location and markings on each boundary or corner monument is as follows:
