

# Certificate of Location of Lode Mining Claim

- Corner No. 6 is a 4" dia. x 5' plastic pipe with scribed metal tag.

The monumentation and marking of the corners was completed by the 13th day of September 1979.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
