DECREE SETTLING FIRST AND FINAL
ACCOUNT AND PETITION FOR DISTRIBUTION

RAY CORTA, Administrator of the Estate of the above-named Decedent, having on the 21st day of September, 1979, rendered and filed herein his First and Final Account and Petition for Distribution, and hearing on said Account and Petition having been set for the 3rd day of October, 1979, at the hour of 2:00 p.m., and proof having been made to the satisfaction of the Court that due and legal notice of the settlement of said Account and the hearing on said Petition for Distribution having been given as required by law, the Court hereby finds:

1. That the Administrator filed no statement of money received or money disbursed, for the reason that the only heir, ALICE CORTA, surviving wife of the Decedent herein, waived her right to an account by written waiver on file herein, and therefore, the rendition and settlement of a detailed account as such Administrator is not necessary or required, other than to show the payments of all debts and any expenses of administration, and by the filing of the Petition, the Petitioner in his individual capacity, waived any accounting or the filing of any detailed

1 statement of money received and disbursed.

2 2. That due and legal Notice to Creditors of said
3 Estate has been given in the manner and for the time required
4 by law.

5 3. That there was one Creditor's Claim filed against
6 the Estate by the Elko General Hospital in the sum of \$6,400.00,
7 which Creditor's Claim has been paid by the Administrator.

8 4. That all taxes of every name and nature required
9 to be paid by Decedent's Estate have been paid. That the Estate
10 tax return has been filed and paid to the Internal Revenue Service.

11 5. That the Administrator engaged Roy Young and Roy
12 Shurtz to appraise the Estate. The payment of the appraiser's fee
13 has been paid out of the Estate account and settled.

14 6. That all of the property and property interests of
15 every name and nature in which Decedent had an interest at the
16 date of his death was community property of which one-half should
17 be confirmed to ALICE CORTA, surviving wife of the Decedent as
18 her community share and that the remaining one-half interest in
19 said property is Decedent's share of the community.

20 7. That there will be closing costs not to exceed the
21 sum of \$100.00.

22 8. That the Administrator having waived his right to
23 the allowance for any payment of statutory fees and commissions
24 for services as Administrator none be allowed.

25 9. That the heirs-at-law of the Decedent are as

3 WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

4 A. That due and legal notice of the hearing of said
5 First and Final Account and Petition for Distribution was given
6 as required by law. That the First and Final Account of said
7 Administrator be, and the same hereby is, finally settled, allowed
8 and approved.

9 B. That due and legal Notice to Creditors of said
10 Estate was given in the manner and for the time required by law.

11 C. That the Administrator having waived his statutory
12 fees and commissions none be allowed.

13 D. That the sum of \$100.00 be, and hereby is, set
14 aside for closing costs.

15 E. That all of the property and property interest of
16 every name and nature in which Decedent had an interest at the
17 date of his death was community property of which one-half is
18 confirmed to ALICE CORTA, surviving wife of the Decedent, as her
19 community share, and the remaining one-half interest in said
20 property is Decedent's share of the community. That the Decedent
21 and his wife owned an undivided 75% interest in the hereinafter
22 described real and personal property. That the interest of the
23 Decedent to be distributed to ALICE CORTA is as follows:

24 An undivided thirty seven and one-half percent interest
25 in and to that certain real and personal property situate, lying

 the public domain in cooperation with the Bureau of
 Land Management, and all of the Decedent's right
 31 in and to any and all other corrals, improvements or
 structures located on the public domain.

TOGETHER WITH the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TOGETHER WITH an undivided thirty seven and one-half percent interest in and to all livestock, farm equipment and machinery, operating supplies and ranch vehicles.

Thirty seven and one-half percent interest in and to Corta Livestock Company's cash and bank accounts.

Thirty seven and one-half percent interest in and to Corta Livestock Company's Federal Land Bank stock.

That Decedent and his surviving wife, ALICE CORTA, owned as community property a Savings Account at First National Bank of Nevada and a Checking Account at Security National Bank of Nevada. That the one-half interest of the Decedent in said bank accounts be distributed to ALICE CORTA, and the community one-half interest of ALICE CORTA in said bank accounts be confirmed to her.

F. That any and all other property, both real and personal, of any kind or nature, not hereinabove described, but within the jurisdiction of the above-entitled Court in which said Estate may have an interest, whether now known or not, be distributed to ALICE CORTA.

G. That upon filing receipts showing payments and distributions as herein set forth and receipt showing a payment of fees and costs having been duly made, all in accordance with this Decree, said Administrator be discharged.

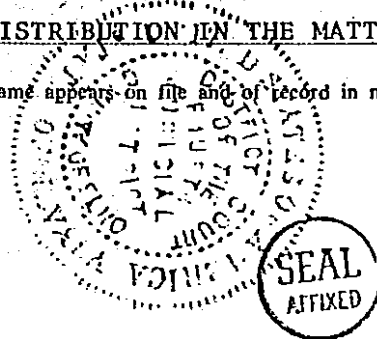
