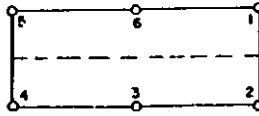
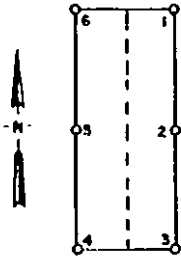

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the M. C. # 68 Lode Mining Claim on this 19 day of October, 1979, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE 1/4 SE (Quarter) Section(s) 25, Township 24 N, Range 48 E, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 750 feet in a South direction to Post No. 2,
