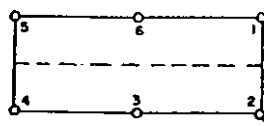
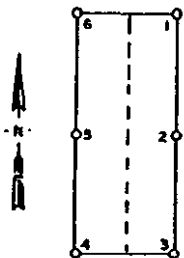

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the M. C. # 109 Lode Mining Claim on this 21 day of October, 1979, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE (Quarter) Section(s) 26, Township 24N, Range 48E, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 750 feet in a South direction to Post No. 2,
- Thence, 750 feet in a South direction to Post No. 3,
- Thence, 600 feet in a West direction to Post No. 4,
- Thence, 750 feet in a North direction to Post No. 5,
