

RELEASE

Pursuant to a "Prospecting Agreement with Option To Lease", made the 9th day of November, 1978, a short form of which was recorded with the county recorder in and for Eureka County, Nevada on December 14, 1978 in book 67 at page 469, hereinafter called the "Agreement", Robert R. Martin, Ruthel Martin, and Albert H. Englebright, hereinafter collectively called the "Optionors", granted unto NL Industries, Inc., hereinafter called the "Optionee", the exclusive right for a period of one (1) year to conduct mineral exploration and development operations in, on and under certain unpatented lode mining claims situated in Eureka County, Nevada, together with an option to lease the said claims.

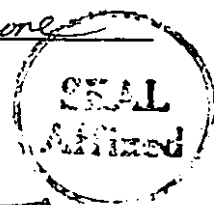
