The general course of the lode deposit and premises is from the Northerly to the Southerly.

- Corner No. 6 is a 4" x 4" WOODEN POST marked N.E. Cor. STOCKTON # 26

The monumentation and marking of the corners was completed by the 30th day of Sept, 1979.
