The general course of the lode deposit and premises is from the Northerly to the Southerly.

- Corner No. 6 is a 4" x 4" WOODEN POST MARKED N.E. COR. STOCKTON #27

The monumentation and marking of the corners was completed by the 30th day of Sept, 1979.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the _____ County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
