

CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that Mineral Ventures, Inc. (a Colorado corporation), whose address is Suite 509 West Point Bldg., 3900 South Wadsworth Boulevard, Lakewood, Colorado 80235, has located the Pinto #5 lode mining claim, and by this certificate and by right of discovery and location claim 1500 feet, linear and horizontal measurement along the vein thereof, with all its dips, angles and variation as, together with 300 feet in width on each side of the center of said vein or lode at the surface, and all veins, lodes, ledges, deposits and surface ground within the boundary lines of said claim 1490 feet on said vein or lode in a West direction from the discovery point and 10 feet in a East direction from the discovery point. The general course of said vein or lode is East to West.

The said claim is situate in the Eureka mining district, Eureka County, State of Nevada.

The NE corner of said claim is located 1500 feet East and 2400 feet South of the quarter corner of Sections 17 & 20, Township 18 North, Range 54 East, Mount Diablo Prime Meridian, Eureka County, Nevada. The said claim lies in the following quarter section(s) NE 1/4 Section 20, SE 1/4 Section 20, SW 1/4 Section 20, NE 1/4 Section 21, Township 18 North, Range 54 East, Mount Diablo Prime Meridian Nevada.

Said lode was discovered and located on the 8 day of November, 1979.
