KNOW ALL MEN BY THESE PRESENTS, that Mineral Ventures, Inc. The said claim lies in the following quarter section(s) NE 1/4 Section 20, NW 1/4 Section 21, SE 1/4 Section 20, SW 1/4 Section 21, Township 18 North, Range 54 East, Mount Diablo Prime Meridian Nevada.

Said lode was discovered and located on the 8 day of November, 1979.
