

MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT is made and entered into as of this 11th day of September, 1979, by and between MAYNARD E. BISONI and Wife, MARY M. BISONI, whose address is Box 152, Eureka, Nevada 89312, and LESTER A. BISONI and Wife, GENEVE G. BISONI, whose address is Box 184, Eureka, Nevada 89312 (hereinafter sometimes referred to as "Optionor"); and BEAR CREEK MINING COMPANY ("Bear Creek"), a Delaware Corporation whose mailing address is Box 9, Dishman Branch, Spokane, Washington 99213.

WHEREAS, Optionor and Bear Creek have executed that certain unrecorded Exploration and Option Agreement dated 8-15-78 ("Option Agreement"), whereby Optionor did grant to Bear Creek, for a term ending on the tenth anniversary of the date of the above-described Option Agreement, "the exclusive right to explore and develop" and "the exclusive option to purchase" those certain unpatented lode mining claims situate in Eureka County, Nevada and described on Exhibit "A" attached hereto and made a part hereof by this reference, and

WHEREAS, the purpose of this Memorandum of Agreement is to give notice to all of the existence of Optionor's and Bear Creek's rights and privileges under the above-described Option Agreement.

NOW, THEREFORE, for and in consideration of the payments to be made and of the obligations to be performed under the above-described Option Agreement, and for other good and valuable considerations, the receipt and sufficiency of which are hereby expressly acknowledged and confessed, Optionor does hereby grant to Bear Creek, its successors and assigns, all of those rights and privileges, set forth in the above-described Option Agreement, for the purposes more specifically set forth in the above-described Option Agreement.

IT IS AGREED BETWEEN Optionor and Bear Creek, their successors and assigns, however, that by this reference to same, all of the terms, provisions, conditions, and covenants of the above-described Option Agreement are incorporated herein and made a part hereof for all pertinent purposes, and Optionor and Bear Creek do hereby ratify, adopt, and confirm the above-described Option Agreement and all of the terms, provisions, conditions, and covenants thereof.

THIS MEMORANDUM OF AGREEMENT may be executed in any number of counterparts with the same effect as if all parties had executed the same document.

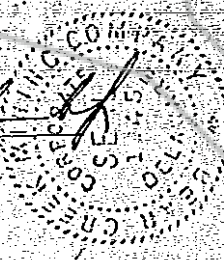

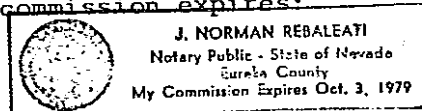

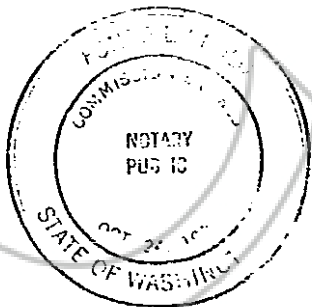
