The Claim is 1460 feet long and 600 feet wide, such that 1450 feet is claimed in a WEST direction and 10 feet in a EAST direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the EAST to the WEST direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 8th day of October, 1979.
