The Claim is 1320 feet long and 460 feet wide, such that 660 feet is claimed in a Northerly direction and 660 feet in a Southerly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 230 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the North to the South direction.
