The Claim is 1410 feet long and 590 feet wide, such that 1400 feet is claimed in a westerly direction and 10 feet in an easterly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 295 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the west to the east direction.

The definition of the boundaries of the claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 9<sup>th</sup> day of October, 1979.
