The claim is 1,500 feet long and 600 feet wide, and 100 feet is claimed in a NORTHERLY direction and 1,400 feet in a SOUTHERLY direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and its premises is from the NORTHEAST to the SOUTHWEST.
