DECREE SETTling FIRST AND FINAL
ACCOUNT AND PETITION FOR DISTRIBUTION

DOMINICK PIERETTI, Executor of the Estate of the
above-named Decedent, having on the 29th day of November, 1979,
rendered and filed herein his First and Final Account and
Petition for Distribution, and hearing on said account and
Petition having been set for th 20th day of December, 1979,
at the hour of 1:00 p.m., of said day, and proof having been
made to the satisfaction of the Court that due and legal
notice of the settlement of said Account and the hearing on
said Petition for Distribution having been given as required
by law, the Court hereby finds:

1. That the Executor filed no statement of money
received or money disbursed, for the reason that the only
other heir beside the Petitioner, TOSCA SULLIVAN, surviving
daughter of the Decedent herein, waived her right to an account
by written waiver on file herein, and therefore, the rendition
and settlement of a detailed account as such Executor is not
necessary or required, other than to show the payment of all

1 debts and any expenses of administration, and by the filing
2 of the Petition, the Petitioner in his individual capacity,
3 waived any accounting or the filing of any detailed statement
4 of money received and disbursed.

5 2. That due and legal Notice to Creditors of said
6 Estate has been given in the manner and for the time required
7 by law.

8 3. That there were two Creditor's Claims filed
9 against the Estate by Burns Funeral Home, Inc., in the sum of
10 \$3,107.27 and by Tosca Sullivan in the sum of \$45,000.00 plus
11 accrued interest, which have been paid by the Executor.

12 4. That all taxes of every name and nature required
13 to be paid by Decedent's Estate have been paid. That the
14 Estate tax return has been filed and paid to the Internal
15 Revenue Service.

16 5. That the Executor engaged Roy Young, Roy Shurtz
17 and Vernon Scott to appraise the Estate. That payment of the
18 appraisers' fees has been paid out of the Estate account and
19 settled.

20 6. That all of the property and property interests of
21 every name and nature in which Decedent had an interest at the
22 date of his death was held 75% by the Decedent herein and 25%
23 by the Decedent herein as Trustee under the MARIA PIERETTI
24 TRUST.

25 7. That DOMINICK PIERETTI as Executor be allowed
26 statutory fees and commissions in the sum of \$27,432.00 for
27 services rendered to said Estate.

28 8. That there will be closing costs not to exceed
29 the sum of \$100.00.

30 9. That the devisees and legatees named in Decedent's
31 Will are as follows:

10. That the property in the hands of your Executor for distribution unto the parties entitled thereto is as more fully hereinafter set forth.

11. That in accordance with the terms of the Last Will and Testament of the Decedent, the estate is to be distributed to TOSCA SULLIVAN and DOMINICK PIERETTI, share and share alike.

12. That the Estate is in condition to be closed.

WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

A. That due and legal notice of the hearing of said First and Final Account and Petition for Distribution was given as required by law. That the First and Final Account of said Executor be, and the same hereby is, finally settled, allowed and approved.

B. That due and legal Notice to Creditors of said Estate was given in the manner and for the time required by law.

C. That the Executor be, and he hereby is allowed and paid his statutory fees and commissions in the sum of \$27,432.00.

D. That the sum of \$100.00 be, and hereby is, set aside for closing costs.

E. That all of the property and property interests of every name and nature in which Decedent had an interest at the date of his death was held 75% by the Decedent herein and 25% by the Decedent herein as Trustee under the MARIA PIERETTI TRUST.

F. That in accordance with the terms of the Last

1 Will and Testament of the Decedent herein, after the payment
2 of costs and fees, all property belong to the Estate be, and
3 hereby is, distributed to TOSCA SULLIVAN and DOMINICK PIERRETTI
4 in equal shares. The property to be distributed is as follows:

5 An undivided seventy-five percent interest in and to
6 an undivided one-half interest in and to the following real
7 property situate in the City of Carlin, County of Elko, State of
8 Nevada, more particularly described as follows:

and to any and all other corrals, improvements or
structures located on the public domain.

TOGETHER WITH the tenements, hereditaments and
appurtenances thereunto belonging or in anywise
appertaining, the reversion and reversions, re-
mainder and remainders, rents, issues and profits
thereof.

TOGETHER WITH all livestock, farm equipment and
machinery, operating supplies and ranch vehicles.

TOGETHER WITH the Seven Lazy Y Brand.

1 An undivided seventy-five percent interest in and to
2 the following personal property, more particularly described as
3 follows:

16 this Decree, said Executor shall be discharged.
