

KNOW ALL MEN BY THESE PRESENTS, that Mineral Ventures, Inc. (a Colorado corporation), whose address is Suite 509 West Point Bldg., 3900 South Wadsworth Boulevard, Lakewood, Colorado 80235, has located the Pinto #37 lode mining claim, and by this certificate and by right of discovery and location claim 1500 feet, linear and horizontal measurement along the vein thereof, with all its dips, angles and variation as, together with 300 feet in width on each side of the center of said vein or lode at the surface, and all veins, lodes, ledges, deposits and surface ground within the boundary lines of said claim 1490 feet on said vein or lode in a Easterly direction from the discovery point and 10 feet in a Westerly direction from the discovery point. The said claim lies in the following quarter section(s) SE 1/4 Section 17, SW 1/4 Section 16, — 1/4 Section —, — 1/4 Section —, Township 18 North, Range 54 East, Mount Diablo Prime Meridian Nevada.

Said lode was discovered and located on the 6th day of December, 1977.
