

KNOW ALL MEN BY THESE PRESENTS, that Mineral Ventures, Inc. The said claim lies in the following quarter section(s) NW 1/4 Section 20, SW 1/4 Section 20, — 1/4 Section —, — 1/4 Section —, Township 18 North, Range 54 East, Mount Diablo Prime Meridian Nevada.
