**CERTIFICATE OF LOCATION

The undersigned hereby certifies (certify) that he (she, they) has (have) located the South No. 28 Lode Mining Claim in the following quarter section(s): SW 1/4 & NW 1/4 of Section(s) 2 & 36, Township 34N, 35N, Range 50E, M.D.B.&M., in the Lynn Mining District, in Eureka County, in the State of Nevada, on the 12 day of December, 1979.

The Claim is 1500 feet long and 600 feet wide, such that 100 feet is claimed in a north direction and 1400 feet in a south direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the north to the south direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 12 day of December, 1979.
