The Claim is 1100 feet long and 600 feet wide, such that 1080 feet is claimed in a West direction and 20 feet in a East direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the West to the East direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 27 day of November, 1979.
