

CERTIFICATE OF LOCATION

LODE CLAIM

The undersigned, hereby certifies that They have located a mining claim in the UNNAMED Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the 2 VININI FM. The name of this claim is Jill # 2

The Northeast corner is marked by a 4" ^{PK} x 4" post 4 1/2 feet high inscribed NE corner of JILL # 2, the Northwest corner is marked by a 4" ^{PK} x 4" post 4 1/2 feet high inscribed NW corner of JILL # 2, the Southeast corner is marked by a 4" ^{PK} x 4" post 4 1/2 feet high inscribed SE corner of JILL # 2, the Southwest corner is marked by a 4" ^{PK} x 4" post 4 1/2 feet high inscribed SW corner of JILL # 2. There is a 4" ^{PK} x 4" post 4 1/2 feet high at the center of each side-line.

The discovery work has been done and the location work completed since 14 NOV. 1979. The location work consisted of making a claim map as provided in NRS 517.040. Two copies of the map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim fee has been paid to the county recorder.
