

## CERTIFICATE OF LOCATION

The undersigned, hereby certify LODE CLAIM that They have located a mining claim in the UNNAMED Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the VINNI FM.

The Northeast corner is marked by a 4" x 4" post 4 1/2 feet high inscribed NE corner of JILL #4, the Northwest corner is marked by a 4" x 4" post 4 1/2 feet high inscribed NW corner of JILL #4, the Southeast corner is marked by a 4" x 4" post 4 1/2 feet high inscribed SE corner of JILL #4, the Southwest corner is marked by a 4" x 4" post 4 1/2 feet high inscribed SW corner of JILL #4.
