

CERTIFICATE OF LOCATION

LODE CLAIM

The undersigned, hereby certifies that They have located a mining claim in the UNNAMED Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the VININI FM. The name of this claim is: Jill # 8.

The general course of said lode or vein, as near as it may be described, is EASTERLY and WESTERLY.

The locator S Claims 5 1485 feet in a EASTERLY direction and 15 feet in a WESTERLY direction along the course of said vein or lode each way from the point of discovery with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The location and description of each corner with the markings thereon are as follows:

The Northeast corner is marked by a 4" ^{pvc} x 4" post 4 1/2 feet high inscribed NE corner of JILL # 8 the Northwest corner is marked by a 4" ^{pvc} x 4" post 4 1/2 feet high inscribed NW corner of JILL # 8, the Southeast corner is marked by a 4" x 4" ^{pvc} post 4 1/2 feet high inscribed SE corner of JILL # 8, the Southwest corner is marked by a 4" x 4" ^{pvc} post 4 1/2 feet high inscribed SW corner of JILL # 8. There is a 4" x 4" ^{pvc} post 4 1/2 feet high at the center of each side-line.

The discovery work has been done and the location work completed since 14 NOV. 1979. The location work consisted of making a claim map as provided in NRS 517.040. Two copies of the map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim fee has been paid to the county recorder.
