CERTIFICATE OF LOCATION

The Northeast corner is marked by a 4" x 4" post 4 1/2 feet high inscribed NE corner of JILL # 16 the Northwest corner is marked by a 4" x 4" post 4 1/2 feet high inscribed NW corner of JILL # 16 the Southeast corner is marked by a 4" x 4" post 4 1/2 feet high inscribed SE corner of JILL # 16 the Southwest corner is marked by a 4" x 4" post 4 1/2 feet high inscribed SW corner of JILL # 16. There is a 4" x 4" post 4 1/2 feet high at the center of each side-line.
