## CERTIFICATE OF LOCATION

The undersigned, hereby certifies that they have located a mining claim in the UNNAMED Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the VINNI FM.

The locator S Claim S 15 feet in a EASTERLY direction and 1485 feet in a WESTERLY direction along the course of said vein or lode each way from the point of discovery with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The Northeast corner is marked by a 4" x 4" post 4 1/2 feet high inscribed NE corner of PAULA # 7, the Northwest corner is marked by a 4" x 4" post 4 1/2 feet high inscribed NW corner of PAULA # 7, the Southeast corner is marked by a 4" x 4" post 4 1/2 feet high inscribed SE corner of PAULA # 7, the Southwest corner is marked by a 4" x 4" post 4 1/2 feet high inscribed SW corner of PAULA # 7. There is a 4" x 4" post 4 1/2 feet high at the center of each side-line.
