CERTIFICATE OF LOCATION  
LODE CLAIM

The undersigned, hereby certifies that The V have located a mining claim in the UNNAMED Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the VINNI EM. The name of this claim is Paula # 28.

The locator's Claims 1485 feet in a EASTERLY direction and 15 feet in a WESTERLY direction along the course of said vein or lode each way from the point of discovery with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The Northeast corner is marked by a 4" x 4" post 4 1/2 feet high inscribed NE corner of PAULA # 28, the Northwest corner is marked by a 4" x 4" post 4 1/2 feet high inscribed NW corner of PAULA # 28, the Southeast corner is marked by a 4" x 4" post 4 1/2 feet high inscribed SE corner of PAULA # 28, the Southwest corner is marked by a 4" x 4" post 4 1/2 feet high inscribed SW corner of PAULA # 28. There is a 4" x 4" post 4 1/2 feet high at the center of each side-line.

The discovery work has been done and the location work completed since 14 NOV 1979. The location work consisted of making a claim map as provided in NRS 517.040. Two copies of the map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim fee has been paid to the county recorder.
