

the time for filing or presenting claims has expired, and the estate now is in a condition to be closed.

All claims filed or presented against the estate have been allowed by the executor, and approved by this Court and paid.

All debts of the decedent and of the estate and all expenses of administration thereof except closing expenses have been paid.

All inheritance taxes and personal property taxes due and payable by this estate have been paid.

No federal estate tax return has been made or filed for this estate for the reason that the estate was not sufficient to require such a return and no federal estate tax is due.

No California income taxes or federal income taxes are due and payable by the estate.

The executor has waived his right to compensation for his services rendered in the administration of this estate.

The payment of the sum of \$1,536.05 by the executor to Robert M. Davies and Evan V. Judd, as payment in full of their statutory fees for their services rendered in the administration of this estate should be approved.

All the assets of the estate are the separate property of the decedent.

Distribution should be ordered as prayed for.

It is ordered and adjudged that:

- 1. The administration of the estate is brought to a close.
- The first and final account, petition and report of the executor is settled, allowed, and approved as filed.
- 3. All the acts and transactions of the executor relating to the matters set forth in the account, petition and report are ratified, confirmed, and approved.
- 4. The executor has waived his right to compensation for services rendered in the administration of this estate.
