15 Thor M. Smith, as executor of the will of Alfred Merritt  
16 Smith, also known as Alfred M. Smith and A. M. Smith, deceased,  
17 having heretofore filed his first and final account and report  
18 and petition for its settlement and for final distribution, and  
19 the account and report and petition coming on this day regularly  
20 for hearing, the Court finds:

21 Due notice of the hearing of the petition has been regularly  
22 given as required by law. All the allegations of the petition  
23 are true.

24 Alfred Merritt Smith died testate on November 2, 1968, in  
25 Santa Clara County, California, being at the time of his death  
26 a resident thereof.

27 On December 6, 1968, Thor M. Smith was appointed executor  
28 of the decedent's will. He qualified as executor of the de-  
29 cent's will on that date and ever since has been and now is the  
30 executor of the decedent's will.

31 Notice to creditors has been duly given as required by law,  
32

1 the time for filing or presenting claims has expired, and the  
2 estate now is in a condition to be closed.

3 All claims filed or presented against the estate have been  
4 allowed by the executor, and approved by this Court and paid.

5 All debts of the decedent and of the estate and all expenses  
6 of administration thereof except closing expenses have been paid.

7 All inheritance taxes and personal property taxes due and  
8 payable by this estate have been paid.

9 No federal estate tax return has been made or filed for  
10 this estate for the reason that the estate was not sufficient  
11 to require such a return and no federal estate tax is due.

12 No California income taxes or federal income taxes are due  
13 and payable by the estate.

14 The executor has waived his right to compensation for his  
15 services rendered in the administration of this estate.

16 The payment of the sum of \$1,536.05 by the executor to  
17 Robert M. Davies and Evan V. Judd, as payment in full of their  
18 statutory fees for their services rendered in the administra-  
19 tion of this estate should be approved.

20 All the assets of the estate are the separate property of  
21 the decedent.

22 Distribution should be ordered as prayed for.

23 It is ordered and adjudged that:

- 24 1. The administration of the estate is brought to a close.
- 25 2. The first and final account, petition and report of the  
26 executor is settled, allowed, and approved as filed.
- 27 3. All the acts and transactions of the executor relating  
28 to the matters set forth in the account, petition and report are  
29 ratified, confirmed, and approved.

30 4. The executor has waived his right to compensation for  
31 services rendered in the administration of this estate.

32 5. The payment of the sum of \$1,536.05 by the executor



1 to Robert M. Davies and Evan V. Judd, his attorneys, as payment  
2 in full of their statutory fees for their services rendered in  
3 the administration of this estate is approved.

4 6. Notice to creditors has been duly given as required by  
5 law.

6 7. The California inheritance taxes due and payable by the  
7 estate have been paid.

8 8. The executor is authorized to deduct from the distribu-  
9 tive shares of the persons hereafter named the sums set opposite  
10 their respective names, for inheritance taxes paid by the execu-  
11 tor in their behalf, as follows:

12	Mary Thomas	\$ 70.00
13	Jean Dobey	\$ 132.96
14	Dale Smith	\$ 132.96
15	Thor M. Smith	\$ 132.96

16 9. Under the terms of the will of decedent the estate is  
17 distributed as follows:

18 (a) One thousand dollars to Mary Thomas which has been  
19 paid and the receipt for which is on file.

20 (b) All the rest, residue and remainder in equal  
21 shares to Jean Dobey, Dale Smith and Thor M. Smith.

22 10. Any other property of the estate not now known or dis-  
23 covered which may belong to the estate, or in which the decedent  
24 or the estate may have any interest, is distributed in equal  
25 shares to Jean Dobey, Dale Smith and Thor M. Smith.
