

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the LTB #2 Lode Mining Claim in Section 10415, Township 31 N., Range 51 E in the Safford Mining District, in Eureka County, in the State of Nevada, on the 5th day of Nov, 1979.

The claim is 1500 feet long and 600 feet wide, and 100 feet is claimed in a North direction and 1400 feet in a South direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by an aluminum tag stapled to the post
