## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the under-  
signed, does hereby locate the MC 118 Lode Mining Claim on this  
17 day of JANUARY, 1980, situated in the UNKNOWN Mining  
District, EUREKA County, Nevada.

Said Claim is located in the NE (Quarter) Section(s) 1,  
Township 23N, Range 48E, Mt. Diablo P.M., and more particularly
