## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the MC 121 Lode Mining Claim on this 17 day of JANUARY, 1980, situated in the UNKNOWN Mining District, EUREKA County, Nevada.
