

PARTIAL ASSIGNMENT OF OIL AND GAS LEASES

WHEREAS, J. S. ABERCROMBIE MINERAL COMPANY, INC. is the owner of a thirty-five percent (35%) working interest in and to the leases described in Exhibit "A" attached hereto and made a part hereof for all purposes.

NOW, THEREFORE, for good and valuable consideration in hand paid by MAPCO PRODUCTION COMPANY (hereinafter referred to as "Assignee") Assignor does hereby bargain, sell, convey and assign unto Assignee, its heirs, successors and assigns an undivided one-half (1/2) of the thirty-five percent (35%) working interest of Assignor in and to the leases described in Exhibit "A" hereof; it being the express intent of this instrument to convey an undivided seventeen and one-half percent (17-1/2%) working interest unto Assignee.

This assignment is made subject to the terms and conditions of the oil and gas leases described in Exhibit "A" hereto and to the pro rata share of all existing royalties and overriding royalties and other lease burdens with which such leases may be encumbered. It is further subject to all the terms and conditions of the Letter Agreement dated February 3, 1978, as amended, by and between J. S. Abercrombie Mineral Company, Inc. and Filon Exploration and the Operating Agreement dated February 1, 1979 by and between Aminoil USA Inc., as operator, and J. S. Abercrombie Mineral Company, Inc.

The terms, covenants and conditions hereof shall be binding upon and shall inure to the benefit of Assignor and Assignee and their respective successors and assigns; and such terms, covenants and conditions shall be covenants running with the lands described herein and the leased acreage herein assigned, and each transfer of such land or leased acreage.

This assignment is made without warranty of title, either express or implied.
