

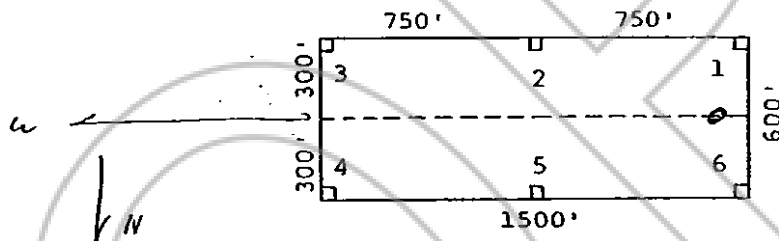

CERTIFICATE OF MINING LOCATION  
LODE CLAIM ON PUBLIC DOMAIN

NOTICE IS HEREBY GIVEN that the Selrat No. 165 lode mining claim has been located by AMERICAN SELCO INC. a New York corporation, whose address is 90 West Grove Street, Suite 100, Reno, Nevada 89509. The general course of this claim is N 87° 0' W. This claim is 1500 feet in length along the course of the claim, being 1490 feet from the point of discovery in a N 87° 0' W direction to the North end line of this claim, and 10 feet in a S 87° 0' E direction to the South end line of the claim. This claim is 600 feet in width, being 300 feet in width on each side of the center line of the claim.

This claim is located within the NE Quarter of Section 20, Township 18 North, Range 53 East, Mount Diablo Base and Meridian, unknown Mining District, Eureka County, Nevada. The location monument of this claim is situated with reference to some natural object or permanent monument as follows: Corner No. 1 of this claim is located appx. 12400 ft. N 53° 0' W from Claim Location Marker SRI. Claim Location Marker SRI a 3' x 6' steel pipe, is located appx.: 1.93 mi. N76°E from Grays Peak; 2.50 mi. N8° E from South Hill Peak; 0.55 mi. S27° W from Surprise Peak.

The corners of this claim are marked by 4"x4" posts or 4" trees with metal tags inscribed with the appropriate corner number as shown on the following sketch and the accompanying claim map.
