SECOND: An Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each Constituent Corporation in accordance with Section 251(c) of the General Corporation Law of the State of Delaware.

THIRD: The name of the surviving corporation is GETTY RESERVE OIL, INC.

FOURTH: The Certificate of Incorporation of GETTY RESERVE OIL, INC. shall continue without change to be the Certificate of Incorporation of the Surviving Corporation.

FIFTH: An executed counterpart of the Agreement of Merger is on file at the principal place of business of GETTY RESERVE OIL, INC., 3810 Wilshire Boulevard, Los Angeles, California 90010 and a copy of said Agreement will be furnished by GETTY RESERVE OIL, INC. on request and without cost, to any stockholder of either Constituent Corporation.

SIXTH: The authorized capital stock of RESERVE OIL, INC. consisted of 1,000 shares of Common Stock, \$1.00 par value.

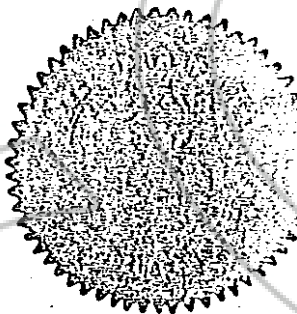
