

Certificate of Location of Lode Mining Claim

The undersigned hereby certifies (certify) that he (she, they) has (have) located the LTP#12 Lode Mining Claim in Section 10, Township 31N, Range 51E in the Elko Mining District, in Eureka County, in the State of Nevada, on the 3rd day of January, 1980.

The claim is 1500 feet long and 600 feet wide, and 750 feet is claimed in a East direction and 750 feet in a West direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by iron nails 1/4" dia. driven to the post.
