

# Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she) has (have) located the BC #5 Lode Mining Claim in Section 28 SW4, Township 23N, Range 48E in the Unknown Mining District, in Eureka County, in the State of Nevada, on the 28th day of February, 1980.

The claim is 1500 feet long and 600 feet wide, and 1480 feet is claimed in a north direction and 20 feet in a south direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the north to the south.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by an inscribed aluminum tag.

Corner No. 1 is a NE-Crn BC #5, 4" diameter PVC post

Corner No. 2 is a ESC BC #5, 4" diameter PVC post

Corner No. 3 is a SE-Crn BC #5, 4" diameter PVC post

Corner No. 4 is a SW-Crn BC #5, 4" diameter PVC post

Corner No. 5 is a WSC BC #5, 4" diameter PVC post

Corner No. 6 is a NW-Crn #5, 4" diameter PVC post

The monumentation and marking of the corners was completed by the 28th day of February, 1980.

(Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
