The general course of the lode deposit and premises is from the north to the south.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by an inscribed aluminum tag

Corner No. 6 is a NW-Crn BC #12, 4" diameter PVC post

The monumentation and marking of the corners was completed by the 28th day of February, 1980.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
