

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that LABRADEX CORPORATION, by its agent, the undersigned, a citizen of the United States, on the 2nd day of March, 1980 located the SAL NO. 27 Lode Mining Claim in accordance with the 1872 Mining Laws of the United States and all subsequent acts, the Mining Location Laws of the State of Nevada, and all local laws, customs, and regulations, and on that day posted a Notice of Location at the place of discovery.

Said claim is located in the Maggie Creek Mining District, Eureka County, Nevada about 4000' in a Northerly direction from Microwave Sta. in Sec. 17. This claim can further be described as being in Section(s) 8, Township(s) 30N, Range(s) 51E, M.D. B.&M.

The general course of said lode or vein is Northerly and Southerly and the locator claims 30 feet in a Southerly direction and 1470 feet in a Northerly direction from the point of discovery together with a width of 700 feet on each side of the center of the vein or lode along the entire length of said claim or a claim 1500 feet by 600 feet in size.

The location work consisted of the preparation of a map of said claim together with other claims in a common group as provided in NRS 517.040. Said map is being filed with and made a part of this Certificate, and was prepared from an actual field survey of this claim.

The corners and side-centers of this claim are located and marked as follows:

From the northeast corner, a post marked N.E. Corner no. 1: SAL NO. 27
 thence Southerly, 150 feet to a post marked East S.C. no. 2: SAL NO. 27
 thence Southerly, 150 feet to a post marked S.E. corner no. 3: SAL NO. 27
 thence Westerly, 600 feet to a post marked S.W. corner no. 4: SAL NO. 27
 thence Northerly, 150 feet to a post marked West S.C. no. 5: SAL NO. 27
 thence Northerly, 150 feet to a post marked N.W. corner no. 6: SAL NO. 27
 thence Easterly, 600 feet to a post marked N.E. Corner no. 1: SAL NO. 27
 the place of beginning.

Each of the above-described corners and side-centers are 4" PVC posts at least 4 1/2 feet in length, set one foot in the ground, and were erected on or before March 21, 1980.
