

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that LABRADEX CORPORATION, by its agent, the undersigned, a citizen of the United States, on the 3rd day of March, 1980 located the SAL no. 60 Lode Mining Claim in accordance with the 1872 Mining Laws of the United States and all subsequent acts, the Mining Location Laws of the State of Nevada, and all local laws, customs, and regulations, and on that day posted a Notice of Location at the place of discovery.

Said claim is located in the Magpie Creek Mining District, Eureka County, Nevada about 300' in a Westerly direction from Millmanville Sta. 16 Sec. 17. This claim can further be described as being in Section(s) 12, Township(s) 32N, Range(s) 50E, M.D. B.&M.

The general course of said lode or vein is Northerly and Southerly and the locator claims 30 feet in a Northerly direction and 1470 feet in a Southerly direction from the point of discovery together with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim or a claim 1500 feet by 600 feet in size.
