THIS IS TO CERTIFY that the "PARADOX No. 2" lode mining claim

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or
vein, extending 750 feet from the location monument in a Westerly direction,
and 750 feet in a Easterly direction, together with 300 feet on
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a post of wood 4"x4"x5 feet high, inscribed "NW Corner
of the "PARADOX No. 2" Claim;" the southwest corner is marked by a post of wood
4"x4"x5 feet high, inscribed "SW Corner of the "PARADOX No. 2" Claim;" the southeast corner is marked by
a post of wood 4"x4"x5 feet high, inscribed "SE Corner of the "PARADOX No. 2" Claim;" the
northeast corner is marked by a post of wood 4"x4"x5 feet high, inscribed "NE Corner of the
"PARADOX No. 2" Claim." There is also a 4"x4"x5 high at the center of each side line.

(must be within 30 days of posting notice of location)
