

CERTIFICATE OF LOCATION  
LODE MINING CLAIM

KNOW ALL MEN BY THESE PRESENTS, that Mineral Ventures, Inc. (a Colorado corporation), has located the Rob #366 lode mining claim, and by this certificate and by right of discovery and location claim 1500 feet, linear and horizontal measurement along the vein thereof, with all its dips, angles and variation as, together with 300 feet in width on each side of the center of said vein or lode at the surface, and all veins, lodes, ledges, deposits and surface ground within the boundary lines of said claim 10 feet on said vein or lode in a Southerly direction from the discovery point and 1490 feet in a Northerly direction from the discovery point. The general course of said vein or lode is North to South.

The northeast corner of said claim is located 15,000 feet North and 10,200 feet West of the NW corner of Sections 12, Township 23 North, Range 49 East, Mount Diablo Prime Meridian, Eureka County, Nevada. The said claim lies in the following quarter section(s) NW 1/4 Section 33, NE 1/4 Section 32, 1/4 Section, 1/4 Section, Township 23 North, Range 49 East, Mount Diablo Prime Meridian Nevada.

Said lode was discovered and located on the 20th day of Feb, 1980.

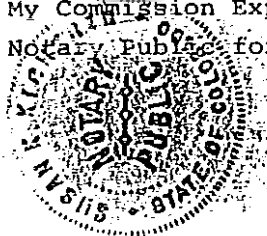
