

SUBORDINATION AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, under date of April 5, 1978  
a certain Oil and Gas Lease was made and entered into by and between  
Walter L. Plaskett and wife, Tommye J. Plaskett, as Lessor, and  
Shell Oil Company, as Lessee,  
recorded in Book 63, Page 512 of \_\_\_\_\_ Records,  
covering the following described land in the County of Eureka,  
State of Nevada, to-wit:

Township 21 North, Range 53 East

Section 1: Lots 3, 4, 5, 6, S $\frac{1}{2}$ N $\frac{1}{2}$ , S $\frac{1}{2}$  less and except, however, a parcel of land in the  
W $\frac{1}{2}$ SW $\frac{1}{4}$  commencing at the Southwest corner of Section 1, the true point of beginning being  
on the Northerly right of way of 11th street; thence continuing North 0°12'00" East  
1407.97 feet along the West line of said Section 1, to corner no. 2; thence from a tangent  
Bearing South 0°12'00" West, on a curve to the left with a radius of 1330.13 feet through  
a central angle of 59°24'47" for an arc length of 1379.28 feet, to corner no. 3; thence  
South 0°02'29" West 261.10 feet to corner no. 4, a point on the Northerly right of way of  
11th street; thence North 89°57'31" West 654.02 feet along the Northerly line of 11th Street  
to corner no. 1, point of beginning.

WHEREAS, the undersigned Nevada Livestock Production Credit Association,  
is the owner and holder of a certain real estate mortgage dated March 8, 1978,  
from Walter L. Plaskett and wife, Tommye J. Plaskett, as Mortgagor,  
to Nevada Livestock Production Credit Association, as Mortgagee,  
securing an indebtedness originally in the amount of Forty Thousand Four Hundred  
Sixty-Seven and 00/100 Dollars (\$ 40,467.00), recorded in  
Book 63, Page 95 of Mortgage Records, covering all  
or some part or portion of the above described land.

NOW THEREFORE, in consideration of the premises and the sum of One Dollar  
(\$1.00) in hand paid, the receipt of which is hereby acknowledged, the undersigned does  
hereby waive the priority of the above-mentioned mortgage over the above mentioned Oil  
and Gas Lease agreement and over the estate of the Lessee under the said Oil and Gas  
Lease agreement, intending hereby that the rights of the undersigned and its successors  
and assigns under the aforesaid mortgage shall be as though the aforesaid Oil and Gas  
Lease agreement were executed and recorded prior to the execution and recording of said  
mortgage, without otherwise affecting the lien of the said mortgage.

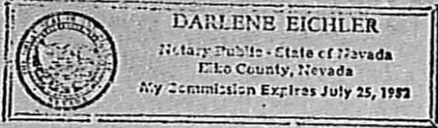
