THIS AGREEMENT MADE AND ENTERED INTO this <u>IOtt</u> day of May, 1976, by and between LUTHER FIORENZI of Eureka, Nevada, first party and ESTELLE FIORENZI McDONOUGH of Las Vegas, Nevada, second party.

That first party and second party in consideration of the mutual benefits to be derived by both parties, do hereby covenant and agree with each other as follows, to-wit:

IT IS AGREED AND UNDERSTOOD that the parties hereto are brother and sister, and the son and daughter of MARY FIORENZI, deceased, formerly of Eureka County, Nevada; that said MARY FIORENZI died intestate on the 26th day of February , 1974, and left an estate and property in Eureka County, Nevada.

IT IS AGREED AND UNDERSTOOD that the said LUTHER FIORENZI is the duly appointed, qualified and acting administrator of the estate of MARY FIORENZI, deceased; that the said LUTHER FIORENZI and ESTELLE FIORENZI McDONOUGH are the only heirs of said MARY FIORENZI, deceased.

IT IS AGREED AND UNDERSTOOD that it is the desire of both first party and second party to reach an agreement as to the division of certain real and personal property left as the estate of the said MARY FIORENZI, deceased.

IT IS AGREED AND UNDERSTOOD that all cash moneys and real property consisting of the houses and lots in the town of Eureka, Nevada will be divided, share and share alike.

IT IS AGREED AND UNDERSTOOD that the ranch property will be divided as follows: 2/3 interest to LUTHER FIGRENZI and 1/3

interest to ESTELLE FIORENZI McDONOUGH; this division is made on the basis that said LUTHER FIORENZI has, over the years, protected said ranch and done work on water rights and maintaining fences and other work necessary to the proper keeping of said ranch property. IT IS AGREED AND UNDERSTOOD that said ESTELLE FIORENZI

McDONOUGH shall receive a partial cash payment of her share of said estate as quickly as said partial payment can be approved by the court.


